

## **CAMP© User Agreement**

(Children's Amputee Mobility Predictor)

This User Agreement governs the use of the CAMP© assessment tool and all related materials, with all rights reserved to authors of the CAMP© and ALYN Hospital. *ALYN Hospital has the right to manage all licenses of the CAMP©.*

### **1. Scope of Use**

This Agreement grants you and your institution (collectively, "User") a non-exclusive, non-transferable, revocable license to use the CAMP© for clinical purposes and non-commercial academic research. "Non-commercial" means research that is not funded by or conducted in collaboration with any for-profit entity and does not involve the delivery of services to third parties.

CAMP© is free to use, provided the following conditions are met.

### **2. Registration Requirement**

Users are required to register their details (full name, institutional affiliation, and position) before receiving access to the CAMP© materials.

### **3. Attribution Requirement**

Any use of the CAMP in publications, presentations, posters, or reports must include appropriate credit to ALYN Hospital as the owner and developer of CAMP©. Citation format will be in accordance with standard scholarly citation practices.

### **4. Restrictions**

- The User may not modify, translate, adapt, or create derivative works based on CAMP© without prior written approval from ALYN Hospital.
- CAMP© may not be reproduced or distributed beyond what is necessary for authorized use under this agreement.
- Commercial use, including commercially sponsored research, consulting services, or product development involving CAMP, is strictly prohibited without a separate written license.

*The User shall have no right to use the names ALYN Hospital, ALYN, or CAMP© except as is incidental to the purposes hereof, without prior approval of the appropriate party.*

## 5. Ownership and Confidentiality

All intellectual property rights to the CAMP© remain exclusively with ALYN Hospital. Any accompanying documentation, methods, or insights are considered confidential. The User agrees not to disclose or share such information with third parties except as necessary to conduct the permitted clinical or academic activities.

## 6. Disclaimer and Limitation of Liability

*The User accepts that the CAMP© is experimental in nature, and that all information or materials are provided “as is”, with no representations or warranties of any kind, express, statutory or implied. To the fullest extent permissible by law, the authors and their respective institutions, and the institutions’ respective officers, directors, employees, physicians, and contractors disclaim all warranties, express, statutory or implied, including, but not limited to, implied warranties of merchantability, fitness for a particular purpose or non-infringement of third party rights with respect to the CAMP©.*

CAMP© is not intended to substitute for professional medical advice, diagnosis, or treatment. ALYN Hospital assumes no responsibility for decisions made or actions taken based on use of CAMP©.

## 7. Termination

This Agreement is effective upon acceptance and will remain in effect for a maximum of 10 years. It may be terminated by either party upon written notice in the event of material breach or institutional dissolution. Upon termination, the User must cease all use and delete any copies of the Tool.

## 8. Governing Agreement

This document represents the full agreement between the User and ALYN Hospital. Any amendments must be made in writing and signed by both parties. If any provision is found unenforceable, the remainder of the agreement shall remain in effect.
